Brush Fire Chars 5 Acres of Reserve

A brush fire thought to be started by youths playing in the reserve burned about five acres near the Safflower Terrace area.

Oviedo Fire and Rescue, Seminole County Fire and Seminole County Sheriff's departments responded to the blaze a little after noon on Tuesday, March 25.

Reserve areas in and



around The Sanctuary are designated as limited access Conservation Areas.

No trespassing signs to that effect are located around the development.

The easement is deeded to the St. Johns River Water Management District and, under Florida law, prohibits or limits

- (a) Construction or placing of buildings, roads, signs, billboards or other advertising, utilities, or other structures on or above the ground.
- (b) Dumping or placing of soil or other substance or material as landfill or dumping or placing of trash, waste, or unsightly or offensive materials.
- (c) Removal or destruction of trees, shrubs, or other vegetation.

It's Time to Get Out There and Plant Those Marigolds

The weather is warming but is not yet unbearable. The rains are starting to become more regular. This can only mean one thing: spring is finally here and now it is time to get to work in your yard.

Hopefully you made that list of the projects you want to get done before the thermometer turns bright red and we all retreat into our homes and crank up the A/C.

By now you should have already cut back the frost damage on your plants and they are beginning to bud back out with new leaves and flowers.

If you have not done this there is still time so get out there and remove the damaged or dead parts of your plants and give them a dose of general fertilizer such as 10-10-10, which you can get from any of the big box stores.

It's also a good time to check your irrigation system. Chances are you may have switched your system off for the winter, check that all your irrigation heads are functioning properly and that you are covering the areas of your yard that you want covered.

You may have to clear out around your irrigation heads if it has been sometime since you used your system. Make sure to check the settings on your timer to be sure that you are watering in compliance with our local irrigation laws [see watering schedule on page 11, ed.].

May is a perfect time of year to replace sections of your lawn, and it's not as hard as you may think.

Start by determining the size of the area that you want to replace and mark it off using marking paint. Next, mix up a general herbicide such as "round up" in a pump sprayer and treat the marked-off area.

It generally takes 10 to 14 days for the area to die off completely.

Once you are satisfied that the turf and or weeds in the area you have treated have died, rake the area using a steel rake to remove the loose material.

Next, set your lawn mower to the lowest setting and use your bagging system and mow the treated area, essentially "scalping" the area. Cover the area with soil, level with a leaf rake and install the sod. You can buy sod by the piece at the big box stores or your local nursery.

You can get a better perfoot price, however, if you by it by the pallet from a sod company such as DUDA or SODKING, both local Oviedo companies. One pallet of St. Augustine has 400 sq. ft. of sod on it. Make sure that you apply for approval from the HOA before starting any projects.

If you are looking to add color to your yard in the form of flowering annuals, marigolds, salvia, torenia, wax begonias and pentas are great choices this time

of year.

Spring also means the return of insects harmful to your landscape and they will become more active as the weather warms. Keep a look-out for scale on your ornamentals.

The warning signs are deposits of white spots on the leaf or trunk. If you find scale on your ornamentals early enough, a mixture of dish soap and cooking oil may remedy the situation.

If the infestation persists, use dish soap and horticultural oil, which you can buy at your local nursery.

If you have oleanders in your yard and you are noticing chewed or ragged leaves this could indicate oleander caterpillars and you will need to treat with a pesticide labeled for use on the caterpillars. You can find these herbicides at your local big box store.

Oviedo Posts Strict Animal Poop Law

Fail to pick up after your pet and Oviedo may swoop in with a \$50 to \$100 fine. That's the bottom line of the new ordinance expected to go into effect in the City if approved.

A main reason for enacting the ordinance is to prevent polluted drainage waters, according to Oviedo stormwater coordinator Amanda Kortus.

Stormwater from The Sanctuary's roads and ponds eventually reaches the Econlockhatchee River whose water quality is already impaired by fecal coliform and other pollution from its Little Econ tributary.

Seminole County already has an animal waste disposal ordinance, but Oviedo's law, the City Council hopes, will provide more incentive for pet owners to do the right thing.

Enforcement, according to city leaders, will likely focus on those neighborhoods (The Sanctuary, Twin Rivers, Ekana Green, Riverside...) that feed the Little Econ drainage.

Included in the Oviedo law is a time limit—24 hours—for homeowners to pick up pet waste in their own yard.

A secondary offense, if added to the ordinance, would fine dog walkers for not carrying a bag along.

Shoveling pet waste from a yard into a storm drain could earn offenders a hefty double penalty for both improper disposal and aquifer pollution.

Wildfire Home Protection Measures

Lars White, Fire Chief, City of Oviedo Fire Rescue Department

Is Your Home Safe from the Threat of a Wildfire?

Although we treasure our beautiful Florida forests and preserves, this vegetation can become a danger to homes during a wildfire event. Homeowners can implement protective measures to reduce the potential damage or complete loss of your home from a wildfire.

A simple assessment of your property in proximity to vegetative or forest areas will allow you to better understand your wildfire risk.

Wildfire Safety Tips

Creating a "defensible space" simply means removing or reducing the vegetation in proximity to your home.

This is the single best practice a homeowner can implement.

- Create a 30 foot vegetation defensive space from your home to a forest area.
- Prune tree limbs that encroach upon your home.
- Avoid stacking firewood next to home.

- Have your fireplace chimney cleaned and inspected once every 5 years.
- Replace mulch adjacent to the home with gravel or rock.
- Eliminate any vegetative fuels that collect on the roof, gutter, or screen enclosure.
- Do not burn lawn or vegetative waste. It's prohibited by city code. Dispose of vegetative waste according to refuge waste provider criteria.
- Monitor seasonal drought conditions recognizing when the wildfire threat is at its most significant period.
- Avoid the use of outdoor fire pits during drought conditions and if utilized always use safe practices such as a spark screen cover, do not use flammable fuels, and keep the fire small. Keep a garden hose ready for use.
- Dial 911 immediately upon discovery of a fire.

- (d) Excavation, dredging, or removal of loam, peat, gravel, soil, rock, or other material substance in such manner as to affect the surface.
- (e) Surface use except for purposes that permit the land or water area to remain predominantly in its natural condition.
- (f) Activities detrimental to drainage, flood control, water conservation, erosion control, soil conservation, or fish and wildlife habitat preservation.
- (g) Acts or uses detrimental to such retention of land or water areas.
- (h) Acts or uses detrimental to the preservation of the structural integrity or physical appearance of sites or properties of historical, architectural, archaeological, or cultural significance. (Fla. Stat. 704.06(1))



These eight paragraphs pretty much limit use of these areas to Florida's real natives: the birds, bugs, bears, snakes, panthers armadillos, raccoons, deer and other critters that crowd into what few natural areas still exist.

If you have children, please tell them the reasons why these lands are set aside for protection.

mental to the future of the region's wildlife.

And if they play with matches in those thick, dry woods...well, you know what happened on March 25.

A timely 911 call and fast action by Oviedo and Seminole County firefighters quickly brought that fire to an end, but the outcome could have been much more serious than four to five acres of charred habitat and a torn up perimeter fence.
