Big Changes Along CR 419

Summer is bringing some significant changes to County Road 419 adjacent The Sanctuary.

MI Homes has started the initial clearing of the property next to us and the fire station prior to construction of the Enclave at Sanctuary, a single-family residential community.

In August you will see significant changes in the traffic pattern at Sanctuary Drive and CR 419. Due to numerous crashes at this location, Seminole County has decided to modify the intersection with a temporary directional median (see diagram at right). All traffic exiting Sanctuary Drive onto CR 419 will have to turn right. If you want to go toward Chuluota on CR 419 or straight across to Riverside, you will have to make a u-turn at the fire station/Primrose School traffic signal.

All traffic from Riverside will turn right onto CR 419. They will have to make a u-turn at the traffic signal by Lawton Chiles Middle School to go toward Oviedo on CR 419.

The current left turns from CR 419 into The Sanctuary or into Riverside will remain the same.

This temporary median is

being installed so they can study the traffic patterns to see if installing a permanent directional median at the cost of \$65,000 will solve the problem, or if the County needs to install a traffic signal at Sanctuary and CR 419 at a cost of \$250,000.

Wildlife on the Prowl

Black bear, Eastern Diamond Back Rattlesnakes, and alligators have been spotted in The Sanctuary this summer.


Our hundreds of acres of conservation land are home to many wild animals. We must be mindful that humans are not the only living things in The Sanctuary.

Wildlife Management constantly cautions that feeding the animals can lead to many unpleasant adventures for both humans and wild creatures alike (it's also against the law in some cases).

Please caution your children to not go into the conservation areas and to keep away from the birds and animals and not feed, chase or frighten them.

closed the pool for a minimum of 24 hours.

Contrary to popular speculation, these closures were not the result of a diapered infant or toddler having an accident in the pool.

All the offending children appear to be over the age of five, when one would assume them to be "potty trained."

Only one parent came forward and admitted it was their child who caused the problem. No parent has cleaned up after their child.

That job, unfortunately was left to your Board.

Federal Laws prohibit us from keeping infants and children from swimming in the pool. We cannot restrict someone under a defined age from the pool. We must be equal across all age groups.

We *can* require anyone in diapers to wear swim diapers with elastic pants over them, but we cannot say that all children 3 and under must wear swim diapers and elastic pants, even though the 3-year-olds have not been the problem.

If anyone has a legal, viable alternative for us to try, please come to our Board Meeting or e-mail the Amenity Center.

It's a jungle in there... Close Encounter of the Venomous Kind

Long-time resident Roger VanDusen's close encounter with a 5-foot-long rattlesnake at the edge of a Sanctuary reserve area should serve as a reminder that it's a jungle in there.

Roger has lived in The Sanctuary since 2001, long before most of the homes were built.

"Since then," he says, "I've seen at least five different types of snakes, all nonvenomous."

Florida, of course, is no stranger to snakes. According to the Florida Museum of Natural History, 50 different species are known inhabitants and 35 of those call central Florida home. Four of the state's six venomous snakes live *nearby*.

Late in May Roger and his 5-year-old grandson, Jameson, were picking some of the wild blackberries that grow along the edge of the woods behind his home.

"It's thick, swampy and

quite beautiful," Roger says. "It's home to many native animals—both big and small—dozens of bird species, insects, frogs, turtles and ...snakes." [*Oh, and don't forget the bears –Ed.*]

"When I heard a hiss, I looked down and saw a huge steward of the environment. But this situation, he felt, posed an immediate threat that needed to be eliminated.

"This thing was 60" long, 5 FEET! It looked very scary and evil," he recounts. "It was right out in my back

My immediate instinct was to grab Jameson and back up as fast as I could."

Roger got Jameson safely into the house and took another look.

Coiled, ready to strike and staring back at him was an Eastern Diamondback, the largest and potentially most venomous of Florida's pit vipers.

After some pondering ("What if it slithers away, out of sight?...What if it heads toward our house, or a neighbor's? ... WHAT IF ONE OF THE MANY KIDS IN MY NEIGHBORHOOD ENCOUNTER IT?") he decided to act.

Roger considers himself an outdoorsman and a good yard where the kids play. In fact, some of the kids regularly go into those same woods to explore!"

Roger later used the event for a neighborhood reality lesson, gathering some of the kids and their parents around the snake's corpse laid out in his driveway.

"The kids were mostly curious, but their parents were very impressed and told the children to STAY OUT OF THOSE WOODS and to STAY ALERT!"

"The reality is this snake had parents and probably siblings and cousins," says Roger. "They're in the woods right now. It's their home and it's best to leave it to them and all the other native critters that live there."

Good advice.

ARC Approval Is the First Step

Plan ahead for projects that need ARC approval. Just about everything you do to the exterior of your property requires ARC approval in advance. And getting approval is not an overnight process.

When you turn in your ARC application form—always your first step in this process—you should expect to wait up to 45 days before you lift a brush or shovel or hammer or tell your contractor to begin work.

After you turn in your application form to the property manager or clubhouse office, it joins a stack of applications from other homeowners just like you. At its monthly meetings the ARC is often faced with dozens of applications. Many require site visits by committee members to verify details in the application.

The committee takes its job seriously to ensure proposed work follows the rules and guidelines established by The Sanctuary's Governing Documents.

Committee members frown on last-minute requests for an immediate decision.

They also *really* frown on work begun before written approval. In fact, anything done before written approval of your request is technically a violation and may be subject to fines or a "redo."

Your project will go much more smoothly (at least from an ARC standpoint) if you follow these three steps:

1. **Complete an ARC application on the proper form.** Make sure you provide needed details, or you may get the form back with a request for more information. Sign the form.

2. **Mail or drop off the form:** to the management company or clubhouse.

3. Wait for the ARC approval—in writing— BEFORE you or your contractor begins work.

Much more information about ARC and your responsibilities is in the Community Development Standards document available from the Website or the management company.

House Paint

The ARC requires advance approval for all exterior colors, even for repainting of the original color.

Some of the original colors, however, are no longer on The Sanctuary's approved color list. When repainting you will have to find a color from the list.

The list and sample chips of approved colors are at the clubhouse. Take a paint color chip with you to accompany your ARC application form.

The Standards document has complete details on house paint approval, beginning on page 26.

Don't rely on your painting contractor or paint store to get the colors right. Make sure YOU know you have the right paint and get ARC approval first.



Vista Community Association Management assists The Sanctuary by effecting the business of the community as directed by the association leadership.


