Annual Meeting:

The Annual Members' Meeting is scheduled for January 24, 2017 at 7pm at the Black Box Theatre at Lawton Chiles Middle School. The annual meeting is critically important for Members to elect the board members as well as consider other issues before the Membership. Fiscal Responsibility & Discipline

The Association is obligated to prudently deploy capital to maintain and improve the health of the community infrastructure, services, and activities. The board accomplished the above maintenance items and investments within its established framework of fiscal discipline. Through November, the Association has once again operated within budget for the year and is on track to do so for 2016.

Wishing to ensure the voice of the Membership was heard, the board shared a full Association Financial Update in late summer (available on the website), and gathered feedback via survey. Your feedback was instrumental in guiding the board to balance community reinvestments/improvements and set a one-time, \$300 credit to reduce retained earnings.



Social Events:

Thank you to everyone who attended this year's social events! Events were well-attended this year with several hundred at the Easter Egg Hunt, Summer Splash, and Fall Festival, with the School's Out Bash breaking the record for the most-attended community event with over 400 attendees! Social events are an important part of building community engagement and we sincerely appreciate those who have volunteered their time to make them a success.

Volunteer Needs for 2017:

The board of directors, ARC, Covenant Enforcement, and Social Committees are comprised entirely of volunteers who dedicate countless hours to The Sanctuary's day-to-day operations.
