We have had a problem at the Amenity Center with the Sandhill Cranes causing damage to cars in the parking lot. They are also attacking the front windows causing a mess at the front entrance, and are becoming aggressive towards people. Apparently they think their reflection is another bird invading their territory.

We asked Florida Fish and Game to relocate them and were told that would not solve the problem. Move them and they return like homing pigeons, even if moved across the state. They said the birds can become aggressive when they are being fed by residents.

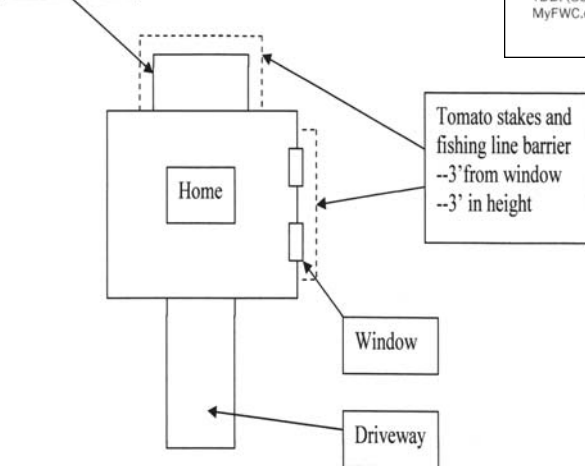
Nuisance Sandhill Cranes have recently been reported in your area. Sandhill Cranes that are fed by people, either directly or indirectly by use of birdfeeders or the feeding of ducks, often lose their fear of humans and begin to associate people with food. Cranes fed in this way often will set up territories in an area and cause damage to window screening, screen doors, screening on pool enclosures, and even vehicle damage. Furthermore, cranes that develop these bad habits often teach their offspring the same behaviors, perpetuating the problem. Because of the numerous calls we receive concerning this issue, the Commission has adopted a rule making it a wildlife violation to feed Sandhill Cranes.

I cannot emphasize enough the numerous ills that can result from feeding wildlife, especially Sandhill Cranes. Feeding wildlife can accelerate the transmission of diseases which normally occur in low concentrations in wild populations. Furthermore, all wild creatures have evolved over the millennia with an instinct to locate and eat a diet best suited to their own digestive systems. Thus, they have their own niche in the wild community where they feed and live in balance with all other members of that community. This balance is interfered with when well-intentioned people feed what they think is a healthy diet to wildlife.

Our advice to anyone who appreciates wildlife is to KEEP IT WILD! The safe and effective way to attract birds and other wildlife is to provide good wildlife habitat. This is best accomplished through the use of native vegetation. We have several excellent publications available on the development of backyard wildlife refuges. They may be obtained simply by writing to this office.

The following are some exclusion methods that may be helpful if you are experiencing damage to your windows, screens, or vehicles due to nuisance Sandhill Cranes. Cranes seem to be attracted to shiny surfaces and reflections provided by windows and vehicles (including vehicle windows and mirrors). One simple way to prevent vehicle damage is to park vehicles in a garage. When this is not possible, use of a vehicle cover is recommended. If cranes are causing damage to windows around your home it is recommended that windows are covered with non-reflective material. If cranes are causing damage to screening on the outside of your home, a barrier can be created using tomato stakes and fishing line preventing the cranes from reaching the screened area (please see attached diagram).

## Screened Patio SANDHILL CRANE EXCLUSION FENCE



This is a diagram showing an exclusion fence that can be constructed to prevent Sandhill Cranes from damaging window or porch screens. The following materials are needed to build the fence:

- Heavy-duty fishing line
- Tomato stakes
- Binder clips (or other fasteners) that will fit tomato stakes

In order to be most effective, the fence should be approximately 3 feet from the window and approximately 3 feet in height. These dimensions allow the barrier to be placed far enough away from the screen so that the cranes will walk into the line before reaching the window, but close enough so that they are not able to jump or fly over the barrier. To construct the exclusion fence, insert tomato stakes firmly into the ground. Then, wrap fishing line around each tomato stake and attach with a binder clip. Repeat the previous step for each tomato stake. The end result will be an exclusion fence that will help prevent the cranes from causing damage to screening outside the home.

# Covenants Corner

Presented By The Sanctuary Covenants Committee

## DID YOU KNOW?

- ✓ Rabbits may be kept as household pets as long as the number does not exceed three per household.
- ✓ Pets shall be kept on a leash when not on the pet owner's lot and shall not be allowed to roam unattended.
- ✓ Pets are not permitted in the common areas and that all residents must clean up after their pets.
- ✓ Boats are not permitted on the ponds.
- ✓ Boats are not to be parked or stored at a homeowner's residence unless it is in the owner's garage (with the exception of temporary parking in the owner's driveway for the purpose of loading and unloading).
- ✓ Homeowners are not permitted to dry or hang laundry of any kind out to dry (sorry no clotheslines).
- ✓ No persons shall clear, landscape, dump anything into, or disturb in any way, the area outside the boundaries of their lot.
- ✓ Chipping or hitting golf balls on Association property is prohibited.
- ✓ Outdoor holiday decorations may be displayed no more than 30 days before and must be removed within 20 days after the holiday.
- ✓ House numbers shall have the assigned house number properly

displayed and follow the Architectural Guidelines.

- ✓ No swimming is allowed in our ponds except in an emergency.
- ✓ No fishing is allowed in lakes with fountains.
- ✓ Mailboxes, if changed, must be approved by the Architectural Review Committee, so as to stay uniform for our neighborhood.
- ✓ Vehicles are only allowed in the Common Area parking lots during normal park hours, except as otherwise approved by permit from the Board or Association managers (e.g., for a special event, private party, etc.).
- ✓ Toy basketball poles are permit-

ted in the front yards but must be removed after sunset.

- ✓ Seminole County has certain restrictions on leasing/renting your home for less than (30) days, and if you have questions you should call the Seminole County Zoning Department.
- ✓ No home shall be owned or used in multiple or time share ownership.
- ✓ Trash containers may be placed in the open after sunset on the night before pick-up day. Such containers shall be stored in garages, behind side yard walls, or on rear porches so that they cannot be seen from surrounding property.
- ✓ Trash containers must have secured lids on them so that the wildlife can not get into them and spread trash all over the yard and street.

✓ Yard trash may be placed in secured bags or tied up for easy pickup.

✓ Vehicles shall not be parked on the lawn, landscaped portion of Common Areas, roadway or other portion of the properties not specifically designed and intended for the parking of vehicles.

✓ No unregistered or inoperable motor vehicle or trailer of any kind may be disassembled, serviced or repaired on the properties except in the case of an emergency breakdown.

✓ To promote a more aesthetic streetscape and safer vehicle access, on-street parking is prohibited except that short-term visitor parking on the roadways is permitted for up

to six hours (this includes both personal and commercial vehicles).

- ✓ Vehicles of residents and their guests are to be parked in garages or driveways (making sure not to block the sidewalk; Oviedo police may ticket vehicles blocking the sidewalk).
- ✓ Prohibited Vehicles that cannot be parked or stored at the homeowner's residence unless inside the garage include (with the exception of loading or unloading):
  - Any vehicle longer than 21 feet or higher than 8 feet.
  - Any commercial vehicle (meaning not designed and used for normal personal/family transportation).
  - Any vehicle bearing commercial lettering, graphics, or other commercial insignia.
  - Recreational vehicles, including campers, mobile and motor homes, all-terrain vehicles and dune buggies.
  - Trailers of any type.
  - Boats.
  - Derelict vehicles, including vehicles with no current license plate, or vehicles incapable of self-propulsion.
- ✓ Homeowners wanting to make any additions to the exterior of their homes must contact the Architectural Review Committee and get approval. An application can be found on our homeowners' website.
- ✓ No owner shall permit their home or lawn to fall into a state of disrepair.

- ✓ No garage may be used for living space.

All of these were taken from the Declaration of Covenants, Conditions, Restrictions and Easements of The Sanctuary Homeowners Association. You should have received a copy of this at your closing when you purchased your home. If not, you can obtain a copy by contacting Don Asher's office and they will print you a copy at a small charge. ## Report from ARC Committee

If you are planning to add a pool or screen enclosure or make alterations to your property, please obtain form for approval from the office or website.

### "FOR SALE" SIGNS

In order to maintain consistent aesthetics within the community, the Board of Directors of The Sanctuary voted for a standard "For Sale" sign to be used by every resident of the community who desires to advertise a house for sale. This was voted on and approved at the May 24th, 2007 Board of Directors' meeting. Details of the ruling as submitted by the The Sanctuary Architectural Review Committee (ARC) are as follows:

Any resident offering a home for sale or lease in The Sanctuary on or after Aug.15, 2007, must use the approved sign. All "For Sale" and "For Lease" signs in the community must be transitioned to the new standard sign no later than Oct. 1, 2007.

In order to obtain a sign, have

your realtor contact Sign Farm at the contact information shown below. In the case of a home "For Sale by Owner," ordering of the sign is the sole responsibility of the homeowner. The wording to be used on signs advertising a home for lease is "Available for Lease," with the appropriate contact information. This is the only wording approved by the ARC.

The maximum allowable text is four lines; this may include: brokerage information, phone number, and contact name. No other forms of advertising, marketing, or promotional material shall be attached to the sign or post.

The cost of the sign is \$95.00, which includes custom lettering, placement, and removal of the sign. After the sale, Sign Farm will also store the signs for the realtor for reuse. The cost of placement and removal for a previously created sign is \$45.00. Sign Farm will also furnish and mount boxes or tubes for circulars at a cost of \$15.00. Sign Farm is the only organization approved by the ARC to furnish these signs.

Please allow three days lead-time for the sign creation and placement or removal.

### SIGN PLACEMENT

- One sign is the maximum on any property.
- No signs are to be placed on trees or other devices.
- Signs should be placed on the approximate centerline of the property and five feet back from the sidewalk.
- If tubes or flat sheet boxes for circulars are mounted, they are to be mounted behind the sign and out of view from the street.

### WIRELESS INTERNET



Wireless Internet access is now available at the Sanctuary Community Center. If you have an 802.11 compatible wireless card or laptop you can connect to the Internet from inside the clubhouse and in some areas around the pool. The connection is a direct connection to the Internet and is not protected by encryption or firewalls so be sure you have virus projection and firewall protection on your computer before using. In other words use the connection at your own computer's risk.



The connection is not broadcast so you will need to have the SSID name in order to connect. Send an email to [webmaster@thesanctuaryhoa.org](mailto:webmaster@thesanctuaryhoa.org) to get access. Please include your full name, Sanctuary address, a contact phone number and your email; also the type of computer operating system you may be using (e.g., Windows XP, Vista, Macintosh, etc.) so we can send you the right documentation. Finally, we will need the MAC address of the wireless card you are using for connection so we can register you on the network.

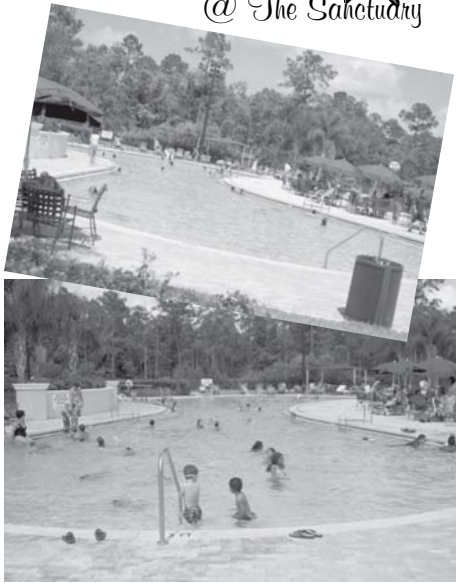

# Toy Motorized Scooters and Florida Vehicle Law

Motorized scooters and go-peds are small two- or three-wheel vehicles powered by gas engine or electric motor. Pocket bikes are miniature motorcycles with 50cc or smaller gas engines.

NONE of these can be legally operated on public roadways, bicycle paths or sidewalks, according to Florida law.

It is not against the law to buy one of these vehicles. But, regardless of what the salesperson tells you, you can only operate them on private property. That means only your own driveway, in your yard or on someone else's private property, with their permission, not on Sanctuary streets or sidewalks. In fact, the only motorized vehicles allowed by law on sidewalks are "Electric Personal Assistive Mobility Devices," a bunch of big words meaning wheelchairs and other devices designed to make life easier for people who may be mobility impaired.

## WHAT ABOUT MOPEDS?

Florida law treats mopeds and motorized bicycles a little differently. Both are motorized vehicles that have pedals and can be operated solely by human power when nec-



essary. mopeds have 50cc or smaller engines and a speed of less than 30 mph. They can be licensed for the streets and legally operated by licensed drivers 16 years of age or older.

Motorized bicycles have electric helper motors and a speed of less than 20 mph. Motorized bicycles don't need to be licensed to go on the streets, but the driver still must be at least 16 years old. If a moped or motorized bicycle is on the sidewalk, it must be under pedal power only.

Whether they are driving or riding on one of these vehicles on private property (or, for that matter, riding a bicycle on a sidewalk or in the street), kids under 16 are required by law to wear a properly fitted and fastened helmet.

## NOT ONLY ILLEGAL, THEY'RE DANGEROUS

You've seen children and young teenagers operating motorized scooters, go-peds and pocket bikes in the Sanctuary. They likely have little or no driving experience or knowledge of traffic laws. On numerous occasions young children have been seen whizzing along the sidewalks, in and out of driveways, not paying atten-


tion to traffic nor obeying stop signs. They are an accident waiting to happen. They are endangering themselves and possibly you, too.

## LEGAL PENALTIES COULD BE SERIOUS

You are encouraged to speak with parents of these children who live near you. Let them know not only of the danger to themselves and others but also that if their child is stopped by a law enforcement officer...

- 1) The parent may be cited for "Permitting an Unauthorized Minor to Drive," and could be arrested.
- 2) The child caught operating a vehicle on a sidewalk can be given a moving traffic citation.
- 3) The child is eligible to receive a criminal citation for operating an unregistered motor vehicle.
- 4) The child may also be subject to a criminal citation, mandatory court appearance and arrest for operating a vehicle without a license.

All criminal violations involve issuance of a Uniform Traffic Citation, mandatory court date and/or arrest.

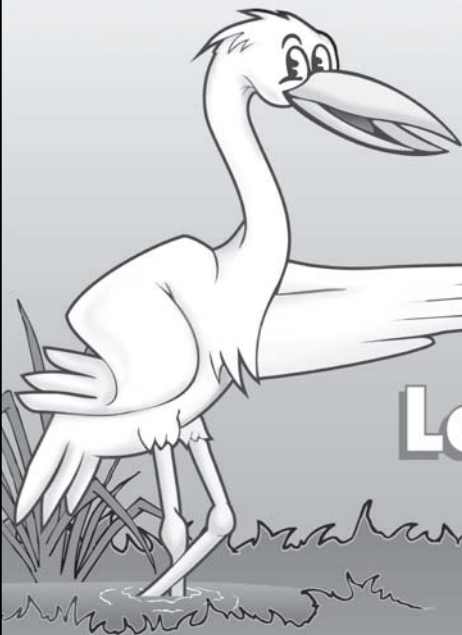
